

#### PRESIDENT REPORT

The relationship with Obesity Surgery Society of India (OSSI) has grown stronger. Jim Byrne, Dimitri Pournaras, Chetan Parmar and I have just returned from attending its annual meeting in Mumbai, a scientific feast twinned with warm hospitality. We were privileged to examine at their FMBS examination. Short-term mutual fellowships have been conceived between the 2 societies, further details to be announced at our forthcoming ASM in Birmingham. We look forward to welcoming our OSSI colleagues to the meeting.

The BOMSS website has several new features, this is constantly evolving, we have a number of guidance documents as well as the BOMSS statement on 'Bariatric Tourism'. We have also developed a joint guidance with BAAPS (British Association of Aesthetic Plastic Surgeons) combining the implications for patients having bariatric and aesthetic surgery outside of the UK. This can be found on the website.

Our work with the National Obesity Audit has also progressed over the last 9 months including quarterly dashboards. NBSR, quite rightly called the 'jewel on our crown', now has almost 90,000 patient records and it is heartening to see a much higher number of operations carried out in the private sector being entered on to the registry. In due course we hope to have real-time meaningful data on pharmacotherapy for obesity and diabetes, which no doubt is a vital additional tool in our armamentarium.

BOMSS monthly webinars and journal clubs continue to be very popular and rich in educational content. Specialist training programmes across multi-professional groups, creation of patient-facing information leaflets, videos, and the development of hands-on training courses have been other highlights. We continue to support and endorse IBC, LIBSS and other valuable scientific meetings in addition to working closely with Obesity Health Alliance (OHA), the Association for the Study of Obesity (ASO) and British Dietetic Association (BDA).

Our relationship with industry is very unique, with corporate partners joining council meetings for the non-restricted part of the agenda. Our partners are fully briefed about the various activities the society undertakes, incorporating their valuable input too.

The negotiations with AUGIS are at a final stage with the deed of transfer going through due diligence. We continue to have reciprocal representation on ALSGBI council, whereby both societies learn from one another and collaborate.

Our forthcoming ASM in Birmingham promises to be exciting, being a central location with good travel connectivity, we are expecting over 350 delegates. Our industry exhibition is sold out, I would urge delegates to visit the stands and engage with them. I am grateful to Mr Martin Wadley, Dr Emma Shuttlewood and colleagues for helping shape up an amazing Training Day programme, catering to all professional groups. Mr Chetan Parmar and team have laid on a scientific feast for the following two days. We will have several international speakers and a number of national figures including Prof Jonathan Valabhji, National Clinical Director for Obesity Care speaking at the inaugural session.

# SECRETARY REPORT

### James Byrne

It is a pleasure to report to you, our members, and to welcome you to our Annual Scientific Meeting, held for the first time in Birmingham this year, for which as I write we currently have over 350 registered attendees. It has been an exciting last 12 months for BOMSS building further on the foundations of our charity, although enormously challenging for NHS battling inflation, industrial action and professional unrest. We are some way off (our vision) of equitable access to safe and effective care for people living with severe and complex obesity across the UK. Continuing to engage with NICE, the NHS and collaboration with other external bodies remains essential so that our and our patients voices are heard. We are immensely grateful to you and colleagues on council for all of the support and work that has been done to enable us to grow and thrive as a professional body.

Our charity is thriving with a total membership of 500, including 180 Consultants, 200 IHPs, 74 trainees, 24 affiliates and 21 students. This level of membership reflects the hard work of council and your President Vinod Menon in particular, and is supported by a superb secretariat at EBS, with Kerri Smith our primary point of contact. We also now have a mailing list of over 1,600 contacts spread all around the world indicating our broad reach.

BOMSS is now in its third year as a fully independent charity has been on a very successful journey since registration with the charities commission in November 2020. We have welcomed the following newly elected members to council in the last 12 months: Nick Carter (Website lead), Aya Musbahi (Equality Diversity and Inclusivity lead), and Dee Wainwright (IHP co-chair of patient safety and clinical standards). Kamal Mahawar has stepped up to lead the NBSR since his election and has established several work packages to deliver the complex tasks required of the NBSR chair including, ongoing funding, publication of COP reports, database upgrades and more besides.

As BOMSS has evolved so too has our trustee body, the purpose of which is to provide oversight and support to the function of BOMSS, and carries with it a number of legal and regulatory roles and responsibilities, whilst council is responsible for making the society work. We are delighted that Cynthia Borg, Sherif Awad and Richard Welbourn have now joined our trustee body.

In addition to the NBSR, our ASM and educational activity during the year BOMSS is also engaged in broader activity. We are acutely aware of the risks of bariatric tourism and have issued guidance on our website as well as a joint statement with BAAPS and engagement with media in this difficult matter. We are professional stakeholders for NICE guidance for Obesity management and treatments and have responded to proposals for new and amended changes to management of weight.

# TREASURER REPORT

### **Ahmed Ahmed**

We continue to enjoy consistently good levels of income through a number of sources including our corporate partnerships programme as well as revenue from membership fees (We currently have total membership of 500 members with subscription rates set to ensure excellent value for money that includes membership of IFSO and access to discounted rates for IFSO) and financially successful scientific meetings over recent years.

We still have substantial funds held by AUGIS and hopefully (following three years of negotiations) we will soon be refunded half of BOMSS funds and all NBSR funds (minus admin costs).

#### Other income sources include:

#### National bariatric surgery registry

NBSR is funded by contributions from trusts performing bariatric surgery and part funded by HQIP at the time when consultant level outcomes were published annually on the NHS choice website. These funds are restricted purely for NBSR costs and upgrades and are not used by BOMSS.

#### Royal College of Surgeons Site specific lead

We previously secured funding of £45K over three years from 2020-2023 and Mr Dimitri Pournaras was appointed to this three year post with the objective of coordinating and encouraging collaboration in bariatric research.

#### **BOMSS ASM 2023 industry sponsors**

#### **BOMSS ASM 2023**

#### **BOMSS** administration

BOMSS is now administered for the third year by Executive Business Support Ltd (EBS), a professional secretariat who also act for the Vascular Society GB&I and a number of other professional bodies. Working with the extended EBS team has been a pleasure and we now have in place financial systems to collect direct debits, payments for scientific meetings and congress directly. Our new systems provide real time financial reporting to support council and the executive in their activities on your behalf. We have also appointed accountancy firm CBSL who are doing the year end accounts for BOMSS CIO.

#### **BOMSS** website

Important updates to the BOMSS website are underway and will enhance the value of your membership of BOMSS and will also act as a resource for our patients, allied health colleagues and the general public. We are currently finalising the development of a GP Hub resource area on the website, which will be launched at the ASM 2023.

I took over as the chair of the National Bariatric Surgery Registry (NBSR) in June 2022 and this is my first report to the council and members in this role. Over the years, Richard Welbourn and then Peter Small have established NBSR as a force for data driven development in the field of bariatric and metabolic surgery and it can only be described as a huge honour to be asked to continue this work. I have to at the outset confess that the task was far more complex than I had initially imagined!

Amongst the very first things, the NBSR committee decided to form several subcommittees to focus on various tasks. A total of seven subcommittees were formed – each with a designated lead – as follows.


- 1. Audit Subcommittee led by Mr. Waleed Al-Khyatt

### NATIONAL BARIATRIC SURGERY REGISTRY (NBSR) COMMITTEE REPORT



### Version 3 Subcommittee Report Subcommittee Lead - Michael Glaysher

Version 2 of NBSR captures essential data for primary and revisional metabolic procedures taking place across the United Kingdom, which has formed the basis for three informative registry reports. When version 2 was launched in 2017, the following amendments were made: (1) Addition of new procedures, (2) paediatric/adolescent surgical fields, (3) QoL assessment, (4) addition of NHS numbers, (5) publishing the names of the hospitals whose total patient records were >10% fewer than they should be according to HES, (6) addition of the percentage of initial patient records that are 'green for complete', and (7) subdivision of revision surgery into major and minor, so as to highlight the work of those who take on higher risk major revisions. Since the launch of version 2, it has been noted that several essential data fields are missing and the functionality of the database may require modification. A third version of the registry aims to address this.

We seek to identify current omissions from and limitations to the current version of the national bariatric surgery registry. These findings will then be incorporated into the design, testing and final launch of version 3. This version seeks to be a user-friendly interface that enhances primary case ascertainment and gathers comprehensive, meaningful data from primary and revisional metabolic procedures across the UK. Particular focus will be on redesigning data fields that would improve the collection of re-admission, complication and correctional surgery data, which links easily to the primary bariatric procedure.



### Reports Subcommittee Report Subcommittee Lead - Andrew Currie

The Reports subcommittee has been focussed on the delivery of the Annual Consultant Outcomes Publication (COP) since the last ASM. This annual report allows us, uniquely for a national bariatric surgery registry, to place procedure and outcomes information into the public domain. The 21/22 report has been published and we are hopeful that the 22/23 report will be published by the time we meet in Birmingham. For the first time this year, we have contributed to the new aggregated data IFSO registry to demonstrate how UK bariatric-metabolic surgery compares to our international counterparts. We have been able to respond to individual contributors and Trust quality assurance teams to provide timely responses regarding data entry questions and we are always open to questions, suggestions and concerns via info@bomss.org. We are reviewing the core data entry items to ensure we are reporting what is meaningful for you, as our highly valued contributors, but also for people with obesity who can look to the NBSR data when considering place and person for their bariatric-metabolic surgery.

We want to thank you for your excellent engagement with the NBSR again this year, as with your valued contribution and data entry we can continue to make the NBSR one of the world's leading bariatric surgery registries.

### **CAG Report**

#### **External Advisor - Oliver Old**

Clinical Outcomes Publication (COP) is an NHS England initiative that aims to publish quality measures at the level of individual consultant, team and unit level. This programme is managed by the Healthcare Quality Improvement Partnership (HQIP). NBSR works with HQIP to ensure our data on outcomes from Bariatric surgery form part of this key publication series. We also submit an annual review to the Confidentiality Advisory Group (CAG) to comply with regulatory requirements for holding patient data.

BOMSS had a great year following on from the success of the 2022 ASM in Brighton. Plenty of educational activities for the benefit of multidisciplinary colleagues involved in managing patients with obesity and trainees with interest in metabolic and bariatric surgery. BOMSS' free educational webinars (supported by our corporate sponsors) allow colleagues from the UK and internationally to network and maintain their CPD. Since inception in January 2021, BOMSS has delivered 51 educational webinars with over 7000 registrations (an average 138 registrations per webinar). A huge amount of effort goes into organising and running these webinars. 

Last year, the NIHR had identified equality and diversity research as one of its key research aims, and it has been my goal to try and look at themes of diversity bias in research. We have created a small research subgroup tasked with looking at diversity bias in obesity research including female, male first and last authorship, funding of research, country of origin, citations and research indices. Over 5,000 papers were reviewed over the last five years with some interesting findings. We aim to publish the results of this later in the year and host a webinar with regards to diversity bias in obesity research.

# TRAINEE REPORT

## Roxanna Zakeri - Trainee Representative

It has been a busy year for bariatric training with the BOMSS trainee membership growing ever stronger. We had a brilliantly successful surgical skills workshop at the BOMSS 2022 ASM Training Day in Brighton, hosted by Will Hawkins and his team at St Richard's Hospital. Thanks to immense support from our industry sponsors, we had a wealth of simulation, dry lab and wet lab stations incorporating stapling, suturing, and energy devices. Delegates ranged from final year medical student to post-CCT fellow with a range of tasks to suit all.

Our collaboration with industry and leading UK units also led to the design of several handson training courses to help bridge the training gap in bariatric surgery.

• The inaugural GORE-BOMSS Fellow Programme for senior trainees started in December 2022 with the Sleeve Gastrectomy Masterclass at University College Hospital, London. Successful applicants attended in-theatre tutorials with cases covering a range of sleeve and hiatal repair techniques. Part 2 took place in March 2023 with a trainee-dedicated series of tutorials covering technical options and complications across the range of bariatric procedures, career advice and ample networking opportunities during and after the course. Fellows were provided the opportunity to attend the GORE annual conference with international experts and fortunate to be hosted at the gala dinner and provided accommodation. Feedback was excellent and we hope to run the programme again next year.

# Roxanna Zakeri - Trainee Representative

- J&J Bariatric Training Pathway remained as popular as ever this year with successful
  applicants attending a programme of lectures, cadaveric training and live operating
  hosted by the Luton & Dunstable team and faculty from across the UK. This holistic
  course provides the foundation in non-technical and technical skills for senior trainees
  prior to launching as a bariatric consultant.
- Medtronic are working with us to develop a bariatric skills programme for more junior trainees, aiming to have satellite sessions across the UK and a flagship session at the new Griffin Institute. Immense support was provided for the ASM training days and the upcoming session at BOMSS 2023 will focus greatly on developing fundamental dissection and haemostasis techniques for trainees new to the field.
- Apollo Endosurgery have continued supporting education in endoscopic bariatric
  procedures and invited trainees to attend the Orbera365 Virtual Centre of Excellence for
  training on intragastric balloon indications, techniques and application to NAFLD. The
  first Endobariatrics course for trainees was also held at Southampton in September 2023
  with leaders in the field teaching endoscopic suturing using the Overstitch device.
  Trainees had the chance to apply this technique to Endoscopic Sleeve Gastroplasty,
  Transoral Outlet Reduction and stent fixation in a wet lab setting.
- The team at Portsmouth held their first cadaveric bariatric surgery course for trainees in March 2023 with two days of lectures and laparoscopic cadaveric operating covering all key aspects of bariatric surgical practice.

We continue to work closely with the Roux Group and held an engaging session at the Roux training weekend in March 2023 covering the future of robotics in bariatrics, emerging endobariatric technologies, indications for revision surgery, and the issues faced by surgical tourism. Feedback was excellent and we continue to have a strong voice within the Upper GI Surgery trainee community.

Establishing collaborative trainee research has also been a priority and we are pleased to now be launching the first trainee-led studies on emergency bariatric surgery, NEBSA and EMBARC. These exciting studies will answer a series of important questions about the delivery of emergency bariatric care across the country and provide invaluable data to guide national policy, so please do register your interest and encourage your peers to join us! Look out for more research opportunities soon – we are looking for the next batch of trainee research leaders to run national multicentre studies.

Increasing the bariatric surgery content of MRCS and FRCS curricula has been an ongoing campaign from BOMSS and we are fortunate to have had increased influence at the Royal College of Surgeons table to help boost awareness of our growing specialty. The global training study conducted by Young IFSO also included UK training pathways and will be published soon. This will help to promote our need for greater exposure to bariatrics earlier on in surgical training careers to ultimately match global opportunities and expectations.

Finally, it is now the 3rd year of our BOMSS Journal Club series. Each month, trainee enthusiasm to present important recent publications has been boundless and I thank you all for helping to ensure we have had trainee representation at every session since January 2021! The series continues to attract a large audience and will rotate around the country so if you would like to present a session from your unit – perhaps you have a new paper you'd like to advertise or are interested in practising critical analysis for exams – then please do get in touch.

Thank you all so much for all you feedback and participation in trainee events this year. It has been my absolute privilege and pleasure to represent my peers' education and career needs to BOMSS Council over the past couple of years. I hope you feel that access to bariatric training has improved and to have enthused many more to pursue a career in this fantastic and ever-developing specialty. Elections for the next trainee representative will take place in June 2023 so the ASM presents the perfect opportunity for those interested in the role to begin the campaign trail!

# RESEARCH REPORT

# Dimitri Pournaras, Roxanna Zakeri, Sally Abbott and Yitka Graham - BOMSS Council Members

The BOMSS research team expanded further this year with the appointment of Roxanna Zakeri as the Associate Surgical Specialty Lead, assisting Dimitri Pournaras (RCSEng-BOMSS SSL) in developing research capability and capacity in the UK.

Establishing research collaboratives has been a priority and we now have active Dietetic and Trainee networks, with Psychology and other discipline groups in the pipeline.

The BARI-DIET collaborative led by Sally Abbott has paved the way and designed, executed and published their first study in an impressively short timeframe. The study is a national, multicentre audit examining variation and effectiveness of liver-reducing diets prior to bariatric surgery. The paper is available open access published in SOARD and you can read it here. The next BARI-DIET study led by Guy Holt will examine fidelity in clinical practice to BOMSS (2020) nutritional guidelines, and will also assess the impact of remote delivery of care during COVID-19 on patients' uptake of nutritional blood tests. This study is now recruiting sites to submit their data, so please contact Guy via email (guy.holt@nhs.net) if interested to join. Both BARI-DIET studies have been funded by research grants from the British Dietetic Association Obesity Specialist Group.

The first trainee-led national collaborative studies in bariatrics are now launching. The National Emergency Bariatric Surgery Audit (NEBSA) and Emergency Bariatric Surgery in the COVID pandemic (EMBARC) studies will focus on the management of bariatric emergencies in the UK, aiming to guide policy updates to longstanding BOMSS guidelines. NEBSA is a prospective cross-sectional study examining the clinical management of post-bariatric procedure emergencies, addressing clinical and financial implications particularly in light of increasing bariatric tourism. EMBARC study investigates regional pathways for specialist referral of bariatric emergencies and explores clinician attitudes and expectations for optimal management pathways in this field. Funding was successfully obtained in the RCSEng Winter Appeal and further details will be launched soon. Successful funding bids also included a RCSEng COVID Recovery grant to investigate the role of pharmacotherapy in the optimisation of patients with obesity on elective General Surgery waiting lists, led by the University of Bristol.

A qualitative study into exploring the development of a long-term follow up service for bariatric patients in community settings was undertaken in Sunderland and has been published open access <u>here</u>. The research team based at the University of Sunderland are taking this work forward in collaboration with General Practice colleagues and patients.

#### RESEARCH REPORT

The <u>PROMISE CARE study</u> has been funded by a NIHR programme development grant and is led by Helen Parretti, with Emma Shuttlewood also a member of the research team. PROMISE CARE aims to gain a comprehensive understanding of the issues around the delivery of long-term care after bariatric surgery to inform the subsequent development and testing of an intervention or package care. It involves interviews with UK specialist weight management and primary care healthcare professionals, followed by a series of online workshops with patients, healthcare professionals and commissioners. The study is currently recruiting for the interviews, and information on taking part can be found <a href="here">here</a> or you can email the team at <a href="mailto:promise.care@uea.ac.uk">promise.care@uea.ac.uk</a>.

BOMSS continues to support audits and research run by its members. The research team are happy to be contacted for support with study design, funding applications, centre recruitment, and results dissemination. Finally, we will be hosting a launch day for the BOMSS trainee research collaborative at the Royal College of Surgeons of England in the coming months, including sandpit sessions to pitch ideas, study development sessions with expert faculty to advise, inspirational talks from hugely successful trainee-led collaboratives, and BOMSS/SSL support moving forwards for establishing study networks. We look forward to seeing many of you there.

# PATIENT SAFETY COMMITTEE REPORT

# Omar Khan and Chris Pring - Co-Chairs

The Patient Safety Committee (PSC) was originally set up two years ago under the chairmanship of Kamal Mahawar. Since then it has evolved and expanded to undertake a number of projects including publication of an analysis of national clinical incidents related to bariatric surgery; dissemination of information on relevant patient alerts; and developing a process of learning from mortality related to bariatric surgery.

Kamal has now taken on the role of chair of the NBSR and has therefore demitted his role as PSC chair. We would like to thank Kamal for his leadership over the last two years in establishing this committee as an important part of the BOMSS mission.

Since the appointment of two new co-chairs we have taken the opportunity in discussion with the BOMSS council to refine and develop the remit and purpose of the committee to address four related streams of activity:

- 1. Review of mortality and any unexpected ICU admission (as notified by NBSR or as notified by clinicians requesting support in their own case reviews) with a view to disseminating points of learning
- 2. Review of clinical incidents and clinical alerts related to bariatric surgery from various bodies
- 3. Maintain up-to-date guidance on professional standards according to evolving evidence
- 4. Contribute to research and publications related to Patients Safety

In order to help with this expanded remit, we have renamed our body The Patient Safety and Professional Standards' Committee and have recently welcomed Dee Wainwright as our IHP Co-chair. We are in the process of reappointing committee members and we welcome all members with an interest in this area and a bit of time to consider taking on a role with us.
